II. Foreign Currency Deposits Services 5. Account Closing (1) <u>When the Client applies to close a foreign currency demand deposit account, or has cleared a specific currency under such account without closing the entire account and subsequently intends to reactivate such currency, the Client shall, unless otherwise provided below, appear in person</u> at any domestic <u>authorized</u> foreign exchange branch of the Bank with <u>identification documents</u>, passbook (not <u>required</u> for without passbook deposits), and specimen seal <u>on file</u>. <u>i. If the Client is unable to do so in person due to special circumstances, the Client may appoint an agent, or send the completed application form with specimen seal affixed to the Bank by post.</u> <u>ii. If the Client, who has cleared a specific currency under a foreign currency deposit account without closing the entire account, subsequently enters into a separate written agreement with the Bank authorizing the Bank to reactivate such currency, the Client may, subject to the Bank's review and approval, be exempt from the requirement to apply to or appear in person at any domestic authorized foreign exchange branch of the Bank to handle the matters on the reactivating said currency.</u> (2) The Client may clear individual currency <u>within</u> the foreign currency demand deposit account; <u>however, once the final remaining currency has been cleared, the account shall be deemed automatically closed.</u> (omitted below)	II. Foreign Currency Deposit Services 5. Account Closing (1) The Client <u>may</u> close <u>his/her/its</u> foreign currency demand deposit account at any domestic <u>appointed</u> foreign exchange branch of the Bank <u>in person</u> with <u>his/her/its</u> <u>identifications</u>, passbook (not <u>necessary</u> for without passbook deposits) and specimen seal. If the Client is unable to do so in person due to special circumstances, the Client may appoint an agent, or send the completed application form with specimen seal affixed to the Bank by post. (2) The Client may clear individual currency <u>in</u> the foreign currency demand deposit account, however the <u>deposit</u> account <u>will</u> be closed <u>when the last currency is cleared.</u> (omitted below)
